FUND STRATEGY

The Fund uses a bottom-up selection process based on fundamental security analysis, and does not try to replicate a benchmark. The approach is contrarian and value oriented. The Fund seeks to find securities that are depressed in price, out of favor with investors, and trading at a substantial discount to intrinsic value. The portfolio manager emphasizes free cash flow generation, balance sheet quality, and the fundamental strength of a business franchise as attributes to identify the most attractive risk/reward propositions across all market capitalizations. The Fund focuses primarily on the securities of U.S. issuers, but frequently invests in non-U.S. issuers. The portfolio will typically contain 60-80 positions.

QUARTERLY UPDATE

- Equity markets wavered in the third quarter as interest rates rose, central banks reduced bond purchases and investors considered higher costs of capital to corporate and government issuers. Labor markets and consumer spending remain healthy even as housing becomes less affordable. If bond buyers are deterred from further purchases, long-term rates may rise more, further hurting borrowers.
- The U.S. generally performed better than global indices in U.S. Dollar terms. Many investors seem surprised that equity markets have not been negatively impacted more given the drawdown in long-term treasuries, which appears to rival that of equities during the great financial crisis.
- The Tocqueville Fund entered a position in Nike as shares fell due to an uneven COVID-19 recovery in China, excess inventory in the wholesale channel and fears of a broader consumer slow down. Our view is that inventory will clear relatively quickly and the transition from wholesale to ecommerce channels will help margins even if the recovery in China remains slower than expected.
- Another new position was Biomarin, a mid-sized bio-pharma company whose shares have been under pressure for an uneven launch of new product Roctavian (ValRox). However, we believe that the value of their pipeline product, VoxRogo, is not properly reflected in the stock price.
- The last new position was RTX, the defense aerospace manufacturer. RTX shares declined after disclosing defective materials in engine fans for their commercial aerospace business. Following this disclosure, RTX shares are trading as if the entire commercial business is impaired and market share loss is permanent. We believe, however, that the defense business is well positioned for the global threat environment, and the engine fan problem will not result in a permanent loss of market share.
- The Fund opportunistically increased positions in Mayville Engineering, Newmont, Paycom, Texas Pacific Land, and Warner Bros. Discovery. Alphabet and Schrodinger were briefly trimmed then repurchased in a tax driven trade to create a gain to offset a loss while also increasing the basis. Lifecore Biomedical and Lumentum were trimmed while Cintas, Dexcom, Inogen, Match and Paylocity were sold outright.

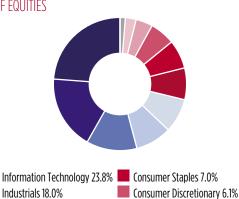

GLOSSARY OF TERMS

P/E: The weighted average of the price/earnings (P/E) ratios of the equity securities referenced. The P/E ratio is calculated by dividing the current price of the stock by the trailing earnings per share for the past 12 months.
