

## FUND STRATEGY

The Fund typically invests in approximately 20 to 25 holdings of small to mid-sized U.S. companies that the portfolio managers believe represent the best equity investment opportunities. The Select Fund applies a "value approach" to investing, seeking to invest in common stocks that the portfolio managers believe are currently undervalued by the market or that represent special situations. The Fund may also invest in other securities, including obligations issued or guaranteed by the U.S. government, its agencies or instrumentalities.

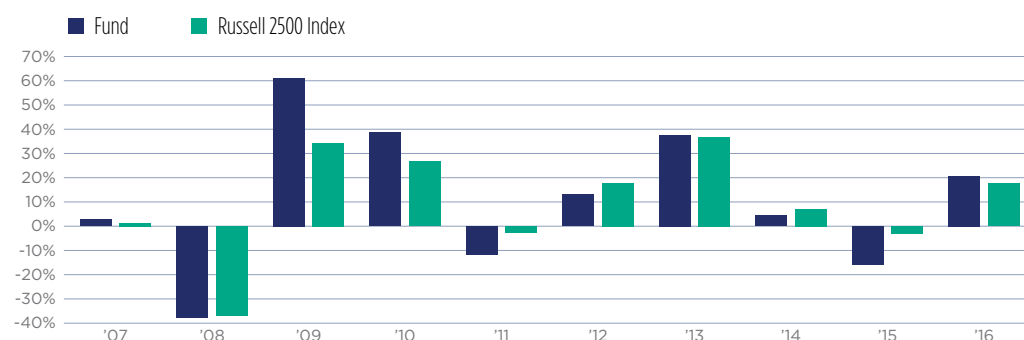

Following the reorganization of the LP into DSF, the LP's returns were adjusted to deduct estimated fees and expenses applicable to DSF's Class Y shares, based on projected asset levels for the first operating year of its Class Y shares (not taking into account any fee waivers or expense reimbursements). DSF and the LP had most of the same Portfolio Managers and substantially identical investment objectives and strategies as The Select Fund. Performance since 9/28/09 reflects actual Select Fund performance.

## QUARTERLY UPDATE

- U.S. equity markets enjoyed another quarter of solid returns, albeit with some pronounced variability from month to month. Investors' trepidation heading into the U.S. presidential election temporarily halted the U.S. equity market's upward march in the month of October. However, equity markets rallied sharply on the heels of the Trump victory in November and U.S. equities held those gains in December, despite the Fed's move to raise rates mid-month. Strong consumer confidence and an improved unemployment report were among the economic data points that buoyed investor confidence during the quarter.
- The Fund had a satisfactory fourth quarter in 2016, generating a return of 9.18%. This compares favorably to both the Russell 2500 and Russell 2000 indices, which increased 6.12% and 8.83%, respectively for the quarter. Our Consumer Discretionary holdings continued to be particularly strong, generating in excess of 300 basis points of relative performance. Our investments in the Materials and Information Technology sectors also contributed favorably to our relative return. The Fund experienced underperformance on a relative basis in the Industrials sector, as well as the Financials space, where the Fund's lack of exposure was a negative, as it was among the better performing sectors during the quarter.
- Pier 1 Imports Inc. was our top contributing stock during the quarter, along with Horizon Global Corporation, J2 Global Inc., and Harsco Corporation which were also very strong. In contrast, Xerium Technologies Inc. was our largest detractor during 4Q 2016.
- There were no new positions taken during the quarter, while we exited our investments, in size order, in Consol Energy Inc., Summer Infant Inc, and Web.com Group Inc.

## FUND OBJECTIVE

The Tocqueville Select Fund's primary investment objective is to achieve long-term capital appreciation by investing in a focused group of primarily small and mid-sized U.S. company equities. Current income is a secondary objective.

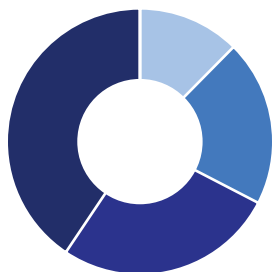

He has a BS from New York University and holds the CFA designation.

Joshua Kaufthal and James Maxwell, CFA, are co-portfolio managers of the Select Fund. Prior to joining Tocqueville in 2009, Mr. Kaufthal spent six years at Delafield Asset Management and three years as an equity analyst in the research department of UBS. He began his career at Bear Stearns as a financial analyst. Mr. Kaufthal earned a BA from the University of Pennsylvania. Prior to joining Tocqueville in 2009, Mr. Maxwell spent three years at Delafield Asset Management. Mr. Maxwell graduated Cum Laude from Northern Arizona University.

## GLOSSARY OF TERMS

**Alpha:** A statistic that measures the Fund's performance above and beyond the market return given its level of risk (as measured by beta). **Beta:** A measure of the Fund's sensitivity to market movements. A beta above or below 1 indicates the Fund is more or less volatile than the market. **P/E:** The weighted average of the price/earnings (P/E) ratios of the equity securities referenced. The P/E ratio is calculated by dividing the current price of the stock by the trailing earnings per share for the past 12 months. **R-Squared:** A statistical measure that represents the percentage of a Fund's movement that is explained by movements in a benchmark index. The higher the R-squared, the more meaningful the beta. **Sharpe Ratio:** A measure of return per unit of risk. A higher ratio indicates better risk adjusted performance. **Standard deviation:** A statistical measure of the volatility of the Fund's returns which is used as a proxy for risk.

**The Russell 2500 Index** is an unmanaged index that measures the performance of the 2,500 smallest companies in the Russell 3000 Index. You cannot invest directly in an index.

**The Russell 2000 Index** consists of the smallest 2000 companies in a group of 3000 U.S. companies in the Russell 3000 Index, as ranked by market capitalization.

**The Morningstar Small-Value Portfolios** invest in small U.S. companies with valuations and growth rates below other small-cap peers.
